Electronic Monitoring Program Introduction

The Door County Jail Electronic Monitoring Program (EMP) is an opportunity that is available to individuals who meet specific qualifications. The program is an alternative to physical confinement within the Door County Jail. This allows an individual to maintain family relationships and fulfill employment responsibilities more efficiently.

The program is a privilege – not a right. The Sheriff or his/her designee will determine who can participate in the program. The courts, probation and parole and the district attorney cannot order an individual into the program, although their recommendations, along with any recommendations from physicians, counselors and family members, will be considered and weighed when making the decision. The individual must be serious about serving their sentence in a cooperative and positive manner. All requests will be reviewed and an extensive background check will be completed. The results of this check, along with any recommendations the individual may have received, will determine if the individual qualifies and will determine the appropriate amount of time they will be placed in the program.

To be eligible for the Electronic Monitoring Program an individual must:

- ✓ Be sentenced with Huber Law Privilege (Wis. 303.08). Individuals in the program must meet the same eligibility requirements as is required of Huber Law inmates serving sentences in the Door County Jail.
- ✓ Not be sentenced to a felony, violent misdemeanor or OWI offense.
- ✓ Complete a minimum of 30 days on Huber in the facility, if approved, the remaining (1/2) half of sentence may be completed on electronic monitoring. **Eligible offenses include all non-violent misdemeanor and criminal traffic convictions, excluding OWI(s).**
- ✓ Not be classified as maximum security through the jail classification process.
- ✓ Have a minimum sentence of 45 days after credits and reductions.
- ✓ Not have active detainers, warrants or holds.
- ✓ Reside in Door County, may be approved to work in Brown or Kewaunee County if employment was established prior to start of sentence.
- ✓ Be current on all debt owed to the Door County Jail, along with the ability to pay applicable program fees.
- ✓ Complete the Electronic Monitoring Program application.

Applicants of the Electronic Monitoring Program must complete the necessary paperwork included in this packet. The packet contains information you will need to know and understand while serving a sentence in the program.
